1. OVERVIEW OF NDA

1.1 The National Development Agency (NDA) reports to Parliament through the Department of Social Development. The NDA is classified as a public entity under schedule 3A of the Public Finance Management Act, 1999 (Act No. 1 of 1999), and was established in November 1998 by the National Development Act, 1998 (Act No. 108 of 1998) (NDA Act) as government's response to the challenge of poverty and its causes in South Africa.

1.2 The NDA derives its mandate from the National Development Agency Act, 1988 (Act No. 108 of 1998). In terms of the Act, the primary objective of the NDA is to contribute towards the eradication of poverty and its causes by granting funds to CSOs for the purposes of:

- (a) carrying out projects or programmes aimed at meeting the development needs of poor communities; and
- (b) strengthening the institutional capacity of other CSOs involved in direct service provision to poor communities.

1.3 The secondary objects of the NDA in terms of the Act are-

- (a) to promote-
 - (i) consultation, dialogue and sharing of development experience between CSOs and relevant organs of State; and
 - (ii) debate on policy development
- (b) to undertake research and publication aimed at providing the basis for development policy.

1.4 The NDA plays a critical role in contributing towards shifting the country from the scourge of poverty towards poverty eradication. Through the Act and various policies, the NDA contributes to – but is not limited to – the advancement of economic development, social cohesion, access to basic human rights and skills development. This contribution of the NDA supports the National Development Plan (NDP) 2030 outcomes for a greater and better South Africa.

1.5 The National Development Plan (NDP), the Medium-Term Strategic Framework (MTSF), Sector Plans and the United Nations Sustainable Development Goals (SDGs)

guide the NDA's functions. The aim of the NDP is in line with the NDA's mandate. The NDP aims to reduce inequality and eliminate poverty by 2030.

2. BACKGROUND

The centre firstly operated at Nazarene Church hence the name Nazarene Edu-care and Pre-school. However, the church activities were interfering with the day-care programme that meant that management had to find another place of operation. In 2011, the centre bought a piece of land from the tribal authority for R2 000 and built a three-room structure. The centre formally registered with the Department of Social Development in 2011 as an NPO and as a Partial Care Facility on the 13th August 2015, number (6/1/4/3/1/2547). It should be noted that the Facility Care certificate has reached expiry date even though the Centre continue to receive DSD subsidy on the understanding that the centre will be constructed by National Development Agency.

On the 28 November 2018, the Ehlanzeni District Municipality issued a certificate of non-compliance to the centre. The implication was that if the centre does not meeting norms and standards it would be closed down. This will imply that the Centre will lose its subsidy currently provided by DSD and children would not have access to early childhood development. The report simply indicate that the existing structure is not conducive. The structure is dilapidated and needs to be demolished and new structure be constructed.

The National Development Agency (NDA) has identified the Nazarene Edu care and Pre-school through Department of Social Development (DSD) as one of the needy centres in the area and allocated a funding for the project towards the construction of ECD Centre. The NDA intervened because the space occupied is not suitable enough and cannot accommodate all the children according to age, which result in rendering the learning ineffective.

3. PURPOSE

The basic purpose is to build a structure for an ECD centre that will provide partial care to children from birth to five years by facilitating access to Early Childhood Development services in order to achieve a safe, secure and stimulating environment for children. This will promote the intellectual, emotional, physical well-being of village children.

Currently, the centre has about 50 children between 0-5 years that would qualify for the ECD services. The ECD is currently accessing a child subsidy of from the Department of Social Development (50 children full attendance).

4. SCOPE AND EXTENT OF WORK

The project entails the construction of an ECD Centre situated at Ward 9, Mgcobaneni village, City of Mbombela.

The building will be approximately 142 m2 in size and will include the following:

1. 3 classrooms
2. Kitchen
3. Centre Manager's office
4. Serving kitchen
5. Restrooms (boys & girls)
6. Water channels

The necessary provision will be made for children with disabilities.

4.1. In total the building will comprise of:

- A mainly masonry structure
- Brick and mortar
- Metal work
- Plumbing
- Electrical installation

The site has been surveyed by a professional surveyor and a full geotechnical study has been conducted.

5. DELIVERABLES AND OUTPUTS:

The special conditions of contract are as follows:

Local labour recruitment: The contractor shall recruit all general workers employed on the contract **basis** from the local community. The **Local Steering Committee** shall provide the contractor with a list of work seekers in these villages and provide guidance on means for contacting them.

Sub contractors: The contractor shall use best endeavours to use sub-contractors located within the **(City of Mbombela Municipality)** area where this is possible without compromising cost or quality.

Materials: The contractor shall use best endeavours to source materials from suppliers located within the **(City of Mbombela Municipality)** area where this is possible without compromising cost or quality.

Local site conditions: The contractor is advised that there electricity from the Eskom network is available during the construction period. The contractor is advised that a water borehole is available and connected with a 10 000 Litres Jojo tank. However, the contractor is advised to source water elsewhere so as not to deplete available water from borehole. The ECD site is also secured with palisade fencing and security is ensured during the construction period.

Environmental: The contractor shall be bound to the NEMA Authorisation and Environmental Management Plan and must comply with all orders (whether verbal or written) given by the Environmental Compliance Officer or Principal Agent in respect thereof.

COVID-19 and Safety Regulations: The contract shall be bound by government regulations and plans must be submitted for such.

Note: Bidders who score less than 70 on technical/functionality evaluation will not be evaluated further.

7. COMMERCIAL EVALUATION (PHASE 2)

7.1 Bids will be evaluated in accordance with the Preferential Procurement Regulations, 2017, using the 80/20 preference points system as prescribed in the Preferential Procurement Policy Framework Act (PPPFA, Act 5 of 2000). The lowest acceptable bid will score 80 points for price and maximum of 20 points will be awarded for attaining the Broad-Based Black Economic Empowerment (B-BBEE) status level of contribution.

7.2 The bid proposals received will be evaluated in two (2) phases. On the first phase bids will be evaluated on functionality and on the second phase in accordance with the 80/20 preference points system respectively.

7.3 Bid proposal must score a minimum of seventy (70) points or more out of hundred (100) points on functionality in order to qualify for advancement to the next phase of evaluation. Second phase, a bid proposal scoring less than 70 out of 100 will not be considered for further evaluation and will be disqualified.

7.4 Phase two: During this phase, bid proposals that passed the first phase will be further evaluated based on the 80/20 preference points system in accordance with the PPPFA

Act, where 80 points will be attained in respect of price (the lowest acceptable bid will score 80 points and bidders that quoted higher prices will score lower points for price on a pro-rata basis) and 20 points will be awarded for attaining the Broad-Based Economic Empowerment (B-BBEE) status level of contribution in accordance with the table below:

7.5 In order to claim the B-BBEE Status Level of Contributor, bidders must submit Sworn Affidavits or original and valid B-BBEE Status Level Verification Certificates or certified copies thereof, issued by accredited Verification Agencies such as SANAS or Registered Auditor approved by the IRBA together with their bids, to substantiate their B-BBEE claims. Exempted Micro Enterprises must submit a letter from the Accounting Officer who is appointed in terms of the Close Corporation Act.

7.6 Bidders who do not submit B-BBEE Status Level Verification Certificate or are non-compliant contributors to B-BBEE do not qualify for preference points for B-BBEE, but will not be disqualified from the bidding process. They will score points out of 80 for price only and zero (0) points out of 20 for B-BBEE.

7.7 Bidders are requested to complete the preference claim form (SBD 6.1) in order to claim preference points.

7.8 A tender will be awarded to the tenderer who scored the highest total number of points in terms of the preference point systems (price and B-BBEE points). It should be noted that the NDA reserves the right not to appoint any bidder and no bidder will be reimbursed for any costs incurred whilst participating in this bid.

8. JOINT VENTURES, CONSORTIUMS AND TRUSTS

A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.

A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity if the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.

Bidders must submit concrete proof of the existence of joint ventures and/or consortium arrangements. The NDA will accept signed agreements as acceptable proof of the existence of a joint venture and/or consortium arrangement.

When bidding through a Joint Venture, the Joint Ventures must submit a Consolidated B-BBEE certificate if it is not an incorporated entity when responding to tenders. This means that the bidder will have to obtain a new B-BBEE certificate for the Joint Venture, which consolidates each participant's B-BBEE status level.

9. SUB-CONTRACTING

Bidders/ tenderers who want to claim Preference points will have to fully comply with regulation 5 and 12(3) of the Preferential Procurement Regulations 2017 about sub-contracting which states that:

"(5) A tenderer may not be awarded points for B-BBEE status level of contributor if the tender documents indicate that the tenderer intends subcontracting more than 25% of the value of the contract to any other person not qualifying for at least the points that the tenderer qualifies for unless the intended subcontractor is an EME that has capability to execute the subcontract.

12 (3) A person awarded a contract may not subcontract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level of contributor than the person concerned unless the contract is subcontracted to an EME that has the capability and ability to execute the subcontract.

10. CLIENT BASE

The NDA reserves the right to contact references during the evaluation and adjudication process to obtain information.

11. PRICING

11.1 Bidders must submit a detailed cost breakdown for all applicable costs e.g. Initial setup costs, monthly costs, and any other applicable costs. All prices submitted must be inclusive of VAT.

11.2 Bidders must indicate if their prices will be fixed and firm for the duration of the proposed contract period, if not, the proposed escalations should be clearly indicated.

11.3 Bidders must ensure that the quotes submitted have no arithmetic errors as NDA will not rectify any errors and no adjustments to quotations received will be permitted.

11.4 Bidders will carry the responsibility of ensuring that the proposals submitted have been signed by a dully authorised person. Should it be established after the submission of proposals that the signatory authorising the proposal is not legally appointed by the service provider, the offer/proposal will be disqualified from the evaluation process.

11.5 All prices submitted should be typed in black ink or written in pen, proposals written in pencil will not be accepted and evaluated.

11.6 A two-envelope system will be used for the submission of proposals.

12. TENDER VALIDITY

All submitted bids must be valid for 150-days from the closing date of this bid.

13. NDA PAYMENT TERMS

Invoices will be paid 30-days from the date of submission and approval.

14. MANDATORY DOCUMENTS

- 14.1. Valid Tax Clearance Certificate issued by the South African Revenue Services (SARS). Where consortium/joint ventures/sub-contractor are involved each party to the association must submit a separate valid original Tax Clearance Certificate or SARS tax Pin or a CSD report.
- 14.2. Company registration documents (CIPC).
- 14.3. A letter/resolution authorising the person signing the bid documents and contracts.
- 14.4. All participating bidders must complete, sign and return ALL the attached SBD forms together with their proposals.
- 14.5 Certificate with CIDB – Grade 3 GB PE

Failure to complete and submit any of the attached documents will result in immediate disqualification.

15. CENTRAL SUPPLIER DATABASE

The NDA will not appoint any supplier who is not registered as a prospective supplier on the central supplier database as required in terms of National Treasury Circular No. 3 of 2015/2016 and National Treasury SCM Instruction note 4 of 2016/2017

16. CONTRACT AWARD

A binding contract will be signed after both parties have fully agreed to the scope of work and all terms and conditions. The NDA legal department will develop a draft contract that shall be used as basis to finalise contract terms and conditions.

17. DISCLAIMER

17.1 Whilst all due care has been taken in connection with the preparation of this bid, the NDA makes no representations or warranties that the content in this bid or any information communicated to or provided to bidders during the bidding process is, or will be, accurate, current or complete. The NDA, and its officers and employees will not be liable with respect to any information communicated which is not accurate, current or complete.

17.2 If a bidder finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in the bid or any other information provided by the NDA (other than minor clerical matters); the bidder must promptly notify NDA in writing of such discrepancy,

ambiguity, error or inconsistency in order to afford the NDA an opportunity to consider what corrective action is necessary (if any).

17.3. Any actual discrepancy, ambiguity, error or inconsistency in this bid or any other information provided by the NDA will, if possible, be corrected and provided to all bidders without attribution to the bidder who provided the written notice.

17.4. No representations made by or on behalf of NDA in relation to this bid will be binding on the NDA unless that representation is expressly incorporated into the contract ultimately entered into between NDA and the successful bidder.

18. ADDITIONS AND AMENDMENTS TO THE BID

18.1 The NDA reserves the right to change any information in, or to issue any addendum to this bid before the closing date and time. The NDA its officers and employees will not be liable in connection with either the exercise of, or failure to exercise this right.

18.2 If the NDA exercises its right to change information in terms of clause 21.1 all amendments will be communicated to all bidders.

19. CONTENT PAGE

Participating bidders are required to submit a detailed content page that clearly state (cross reference) where each technical requirement as per **section 8** of this document is placed in their bid documents. Any additional information that we might have missed must be clearly referenced in the content page.

20. PRICE NEGOTIATIONS

As guided by the Implementation Guide Preferential Procurement Regulations, 2017 pertaining to the PPPFA, Act No.5 of 2000, 19.2; the award of this tender may be subjected to price negotiation with the preferred tenderers.

21. SPECIAL CONDITIONS OF THIS BID

NDA reserves the right to;

21.1 To accept part of a tender rather than the whole tender.

- 21.2 To carry out site inspections, product evaluations or explanatory meetings in order to verify the nature and quality of the services offered by the bidder(s), whether before or after adjudication of the Bid.
- 21.3 To correct any mistakes at any stage of the tender that may have been in the Bid documents or occurred at any stage of the tender process.
- 21.4 To cancel and/or terminate the tender process at any stage, including after the Closing Date and/or after presentations have been made, and/or after tenders have been evaluated and/or after the preferred bidder(s) have been notified of their status as such.
- 21.5 Award to multiple bidders based either on size or geographic considerations.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

Bid rigging is, therefore, an agreement between competitors not to compete.
